**1. THE SUPREME COURT OF ORANGE COUNTY HAS DENIED DENNIS D. MARSH'S CLAIM FOR PAYMENT FOR ACCRUED UNUSED LEAVE AND SICK TIME**

Supervisor Bloomfield as stated, Dennis D. Marsh's claim for payment for accrued unused leave and sick time was denied by the Supreme Court. He noted that the Town stood behind our principles and went the course to win. Councilman Cappella pointed out that Mr. Marsh was a salaried employee, not a union member. Unused leave and sick time does not apply to a salaried employee.
